1 District Profile

1.1 Introduction

Ahmednagar is the largest district in area in Maharashtra comprising 14 taluka places. Ahmednagar district is on the fore front in co-operative movement in the country owing to the strong presence of 16 Sugar factories, distilleries, spinning mills, paper mills, milk federation, dairy etc. in the co-operative sector and a few co-operative industrial estates.

The district has well road network connecting it to all the mega markets in the country. It can be said that the district is the 'Gateway' of Marathwada and Vidarbha to Mumbai.

1.2 Climatic Conditions

Ahmednagar District is situated in the rain shadow region of the Western Ghats, Ahmednagar has a hot semi-arid climate.

The climate is hot throughout the year and sweltering during the pre-monsoon months from March to mid-June, whilst monsoon rainfall averages less than a third of that received in Mumbai and about a tenth what is received in Mahabaleshwar on the crest of the mountains.

1.3 Administrative Profile

Ahmednagar district has 14 tehsils viz. Ahmednagar, Akole, Jamkhed, Karjat, Kopergaon, Newasa, Parner, Pathardi, Rahuri, Sangamner, Shevgaon, Shrirampur, Shrigonda and Rahata. There are 14 Panchayat Samities, 18 cities, 1581 villages, 1 Mahanagar Palika, 8 Nagar Parishads and 1311 Gram Panchayats.

At the district level, Collector is the administrative Chief and at tehsil level, Tehsildars are looking after the administration as per Collector's instructions. For rural development, Chief Executive Officer of Zilla Parishad and at block level, Block Development Officers oversee the administration.

Municipal Councils are responsible for urban development of all the tehsils. Ahmednagar district has 4 sub-divisions as mentioned below:

1.4 Location and Geography

Ahmednagar district popularly known as 'Nagar' is one of the important districts of Western Maharashtra, which is situated partly in upper Godavari basin and partly in the Bhima basin. It lies between 18.2-to-19.9-degree North Latitude and 73.9-to-77.5-degree East Longitude.

It is bounded on the north by Nashik district, on the north-east by Aurangabad district, on the north by Beed and Osmanabad districts, on the south by Solapur district and in the west by Pune and Thane district. The total geographical area of Ahmednagar district is 1667 thousand hectares which is 5.53% of the total State Area.

1.5 Demographic Profile

Ahmednagar is one of districts of Maharashtra in India, Ahmednagar District population in 2021 is 4,861,397 (estimates as per Aadhar uidai.gov.in Dec 2020 data). As per 2011 census of India, Ahmednagar District has a population of 4,543,159 in 2011 out of which 2,342,825 are male and 2,200,334 are female.

Literate people are 3,151,890 out of 1,773,355 are male and 1,378,535 are female. People living in Ahmednagar District depend on multiple skills, total workers are 2,204,590 out of which men are 1,300,309 and women are 904,281.

Total 968,974 Cultivators are depended on agriculture farming out of 549,538 are cultivated by men and 419,436 are women. 501,873 people works in agricultural land as labor, men are 243,329 and 258,544 are women. Ahmednagar District sex ratio is 939 females per 1000 of males.

1.6 Logistic Infrastructure Profile

Ahmednagar city has air connectivity by Seaplane service. The port for Seaplane is located at the Mula Dam water reservoir, 30 min away from Ahmednagar City.

Ahmednagar has rail connectivity with Pune, Manmad, Kopergaon, Shirdi, Daund, Goa, Nasik and other metro-cities like New Delhi, Mumbai, Chennai, Kolkata, Bangalore, Ahmedabad also 41 express trains stop at this station.

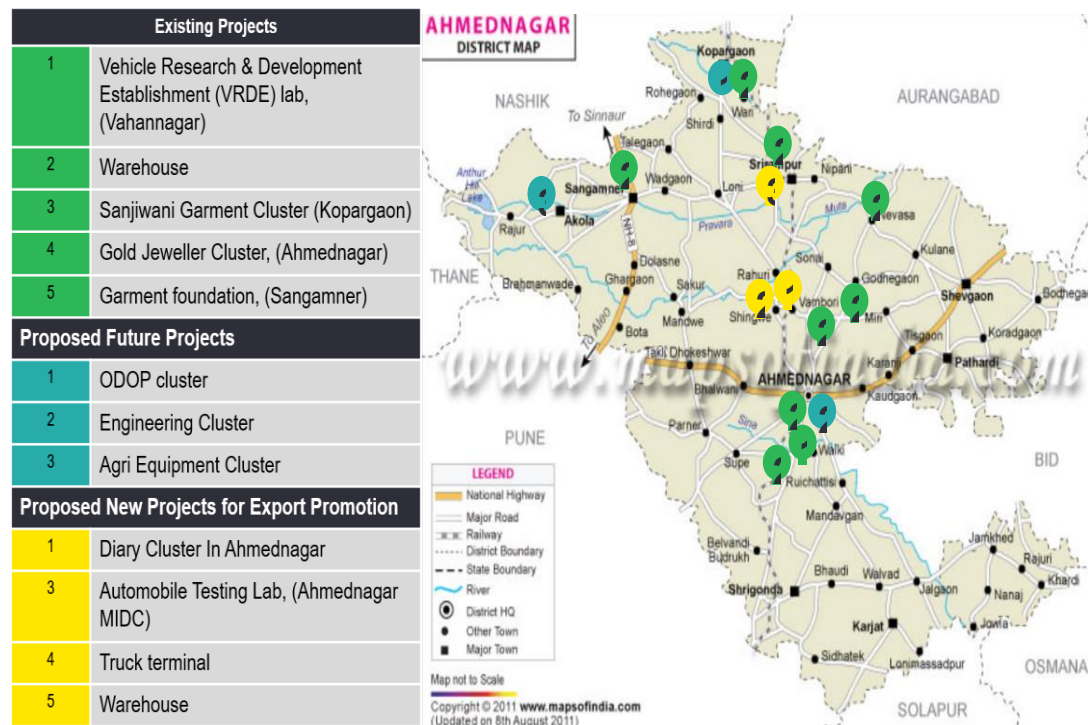
