5. Rules and conditions to obtain the service:

We use Plan for the Time Slot Management to obtain service which is as follows,

The time slot allotment will first come, first serve basis. The members have to book the slot and use the services in the CFC. There will be first preference to SPV members for the time slot booking.

It has been decided to keep separate slots for the Micro/Women/Minority/SC/ST etc. Entrepreneurs to ensure that they will be able to get proper slot availability for processing their product.

Time slot booking can be done by phone or letter. The charges for the services using CFC will be as per the usage of the CFC. There will be the privilege to pay the user charges within 15 days from the usage of the CFC.

The preliminary draft rules for slot booking have been finalized as follows:

- 1. The slot booking has to be done at least 15 days in advance for the desired dates of booking.
- 2. The material has to be reached to the CFC at least 10 days in advance from the slot date of CFC usage.
- 3. The payment of the services to be utilized has to be paid at the time of delivery only. SPV members have the privilege to pay the service charges after 15 days from the date of usage.
- 4. Once the slot is booked, it will not be cancelled in any case.
 Also, 20% of the facility will be reserved for Non-members. It is only if other MSEs do not use these facilities the SPV members will use this quota also.
