## Sub: - Minutes - MAITRI Investor Meeting

MAITRI a Single Window Cell (SWC) is set up with an objective to attract investment and employment in the State. The cell marks a paradigm shift in role of the Government from being a regulator to that of facilitator. It provides G2B services, one-stop-shop for existing and prospective investors to get consolidated information about the investment process with regards to expanding their existing units or to set up a new business unit in the State. MAITRI has been established with the mandate to provide investor facilitation and to guide the investors in obtaining the required approvals for setting up any unit in the state.

As on date, a total of 119 services spread across 15 departments are accessible through the MAITRI-Single Window System. A meeting was organized under the chairmanship of Hon'ble Additional Development Commissioner (Industries) to review the MAITRI cases.

Towards this end, minutes of the meetings are annexed with this Note.

7.			a) Legal Appeals: Vyankatesh Co-Operative Housing Society (VCHS), which owns land adjacent to Kaeser's property in Gat No 300, has filed two appeals (RTS Nos. 6522/2023 and 6523/2023) against Kaeser with the Superintendent of Land Records (SLR) in Pune. The appeals challenge the demarcations done by the Land Records Department in 2017 and 2021, which were not objected to by VCHS in 2022. The SLR, Mr. Suryakant More, upheld the 2017 demarcation as consistent with another demarcation by the Tahasildar of Mulshi in 2019. Despite this, the SLR entertained the appeals and condoned the delays, leading to a stay against Kaeser. The matter is now pending a decision on the stay application.  b) Construction Plan Approval Delays: Kaeser submitted a revised construction plan to the Pune Metropolitan Region Development Authority (PMRDA) on November 29, 2022, but has not yet received approval or a completion certificate. The delay is causing a daily loss of Rs 1,00,000. Despite meeting with the Director of PMRDA, Mr. Rahul Mahiwal, there has been no significant progress.
